Introduction

This Disclaimer governs the provision and use of information, offers, links, and related services provided by Enrollo (operated by Mateusz Jakub Muszarski) via the Enrollo mobile and web application (the “App”). By using the App or clicking any offer, you expressly acknowledge that you have read, understood, and accepted this Disclaimer and agree to be bound by its terms.

This Disclaimer supplements, and does not replace, any separate Terms and Conditions, Privacy Policy, or other legal notices. In the event of any inconsistency, the following order of precedence applies: **(i) Terms and Conditions, (ii) this Disclaimer, and (iii) Privacy Policy.**

Nature of offers, affiliate relationships

The App displays offers from third-party partners (“Partners”). When you interact with a Partner via an affiliate link or complete an offer, Enrollo may receive commissions, fees, or other remuneration from Partners, which does not create any obligation to pay users other than stated Bonuses or Cashbacks.

Offers may be labeled in the App to indicate the source, type, and nature of any reward. Typical labels include (without limitation):

- **“BONUS”** — denotes a reward that Enrollo is obligated to pay **only after** the corresponding Partner has confirmed that the offer was successfully completed and **the funds have been received by**

Enrollo. Payment of a BONUS is subject to verification, anti-fraud checks, and compliance with applicable law.

- **“CASHBACK”** — denotes a reward that Enrollo is obligated to pay **only after** the corresponding Partner has confirmed that the offer was successfully completed and **the funds have been received by Enrollo.** Payment of a CASHBACK is subject to verification, anti-fraud checks, and compliance with applicable law. This value may be subject to a maximum possible payout.
- **“POTENTIAL”** — informational value displayed in the App, based on data provided by partners or advertisers. Enrollo does **not guarantee or pay** any POTENTIAL amounts; they are solely for informational purposes and may differ from actual payouts provided by the partner.
- **“COUPON”** — informational value displayed in the App, based on data provided by partners or advertisers. Enrollo does **not guarantee or return** any COUPON amounts; they are solely for informational purposes and may (but generally should not) differ from the discounts provided by the partner.

A popover or explanatory text is provided in the App to clarify label meanings and distinctions between Partner-paid and Enrollo-paid amounts. Users are encouraged to review these explanations before taking any action.

No guarantee of reward or eligibility

ENROLLO MAKES NO WARRANTY, EXPRESS OR IMPLIED, THAT PARTICIPATION IN ANY OFFER WILL RESULT IN PAYMENT FROM A PARTNER OR ENROLLO. Receipt of any reward depends on compliance with the Partner’s eligibility criteria, internal verification, and anti-fraud processes.

Where Enrollo indicates a discretionary reward (“BONUS” or “CASHBACK”), any payment is conditional upon:

- Your satisfaction of the Partner’s and Enrollo’s stated requirements;
- Availability of funds and processing capacity;
- Verification of account and payment details;
- Compliance with applicable law; and
- Absence of suspected fraud or abuse.

Enrollo is not obliged to make payments in cases where a Partner declines, reverses, or blocks the payment, or if Enrollo reasonably suspects fraudulent or abusive activity.

Partner terms and third-party control

Enrollo disclaims liability for Partners’ tracking, privacy practices, or the accuracy, completeness, or timeliness of Partner-provided information.

Your responsibilities
